CUSTOMS POWER OF ATTORNEY



granting authority to prepare export declarations and documentation

We herewith appoint and authorise, until revocation in writing, the company:

in our name and for our account as well as in their own name and for our account, on the basis of the General Conditions of Business for Forwarding Companies in Germany (ADSp) (**), to transact all customs business in connection with export consignments sent on our behalf, to prepare the necessary export declarations, legally sign these declarations (if required) and to execute all acts and make all signatures in connection with customs clearance.

The undersigned herewith confirms:

- 6.) We are responsible for any obligations in connection with foreign trade legislation. We have complied with all embargo regulations, bans and restrictions, as well as any other restrictions, especially in connection with customs law and international and/or political measures affecting international trade.
- 7.) We assume the responsibility for the completeness and correctness of all documents and information required in order to process the orders.
- 8.) The agent is entitled to grant sub-powers of attorney.
- 9.) We are entitled to deduct input VAT in full (*).
- 10.) The recipient of the power of attorney has named a central contact person.
- 11.) Any alterations/additions to this power of attorney must be made in writing and confirmed by the agent.

(**) We operate exclusively in accordance with the General Conditions of Business for Forwarding Companies in Germany, in the last amended version. Pursuant to No. 23 of these conditions, the statutory liability for damage to merchandise in the safekeeping of forwarding companies in accordance with § 431 of the German Commercial Code (HGB), is restricted to 5 euros/kg; for multimodal transport including transport by sea to 2 SDR/kg, and further, for each case or event of damage to 1 or 2 million euros respectively or 2 SDR/kg, depending on which amount is higher. No. 27 of the ADSp does not constitute a waiver of liability in the sense of Art. 25 of the Montreal Convention.
